## PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND PARAGRAPH 1 OF SCHEDULE 14 AND WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53A(2)

THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (FOOTPATHS 16 AND 17 LITTLE BRICKHILL (PARTS)) PUBLIC PATH DIVERSION ORDER 2021

The above Order was made on 18 May 2021. The effect of the Order will be as follows;-

1) To divert part of Public Footpath 16 Little Brickhill from point A at its junction with Public Footpath 17. Little Brickhill at OS Grid Reference SP 89007 33274 in a general south easterly direction for approximately 467 metres to point D at OS Grid Reference SP 89234 32868. This existing path has a length of approximately 467 metres and a width of 1 metre throughout and is indicated on the Order map by a bold black continuous line. The Order will then create an alternative footpath running from point A at its junction with Public Footpath 17. Little Brickhill at OS Grid Reference SP 89007 33274 in a general south easterly direction for approximately 110 metres to point K at OS Grid Reference SP 89058 33180, then in a general southerly direction for approximately 18 metres to point L at OS Grid Reference SP 89057 33162, then in a general easterly direction for approximately 25 metres to point M at OS Grid Reference SP 89082 33158, then continuing in a general south westerly direction for approximately 15 metres to point N at OS Grid Reference SP 89072 33146, then in a general south easterly direction for approximately 244 metres to point O at OS Grid Reference SP 89201 32939, then travelling in a general south westerly direction for 7 metres to point P at OS Grid Reference SP 89196 32935, then in a general south easterly direction for 43 metres to point Q at OS Grid Reference SP 89221 32901, then in a general south westerly direction for 16 metres to point R at OS Grid Reference SP 89212 32888, then continuing in a general south south easterly direction for 10 metres to point S at OS Grid Reference SP 89216 32879, then in a general south easterly direction for 23 metres to point D at OS Grid Reference SP 89234 32868.

The alternative footpath will travel upon a hard surface and have a length of approximately 511 metres and a width of 2 metres throughout and is indicated on the Order map by bold black dashed lines.

2) To divert part of Public Footpath 17 Little Brickhill from point A along a grass surface path at OS Grid Reference SP 89007 33274, in a south south westerly direction for approximately 294 metres to point C at OS Grid Reference SP 88913 32995. This existing path has a length of approximately 294 metres and a width of 1 metre throughout and is indicated on the Order map by a bold black continuous line. The Order will then create an alternative footpath running from point A at OS Grid Reference SP 89007 33274 in a general south south westerly direction for approximately 94 metres to point E at OS Grid Reference SP 88957 33195, then in a general southerly direction for approximately 13 metres to point F at OS Grid Reference SP 88957 33182, then travelling in a general south south westerly direction for approximately 23 metres to point G at OS Grid Reference SP 88942 33166, continuing in a general southerly direction for approximately 86 metres to point B at OS Grid Reference SP 88930 33081, then

in a general southerly direction for approximately 47 metres to point H at OS Grid Reference SP 88921 33035, then in a general south easterly direction for approximately 40 metres to point I at OS Grid Reference SP 88944 33003, then travelling in a general south westerly direction for approximately 12 metres to point J at OS Grid Reference SP 88935 32996, then continuing in a general westerly direction for approximately 22 metres to point C at OS Grid Reference SP 88913 32995.

The alternative footpath will travel upon a hard surface and will have a length of approximately 337 metres and a width of 2 metres throughout and is indicated on the Order map by bold black dashed lines.
